No.SO(E&M)2-213/2020(LHC).- In exercise of the powers conferred under section 43 of the Provincial Motor Vehicles Ordinance, 1965 (XIX of 1965), Governor of the Punjab is pleased to propose the following amendments in the Punjab Motor Vehicles Rules, 1969. As required under section 119 of the Provincial Motor Vehicles Ordinance, 1965, (XIX of 1965), the draft of the proposed amendments is hereby published for information of the persons likely to be affected and notice is hereby given that the objections and suggestions, if any, in respect of the proposed amendments, may be conveyed to the office of the Secretary Government of the Punjab, Excise, Taxation and Narcotics Control Department within fifteen (15) days of the publication of this notification in the official Gazette and that shall be taken into consideration on ~~15.01.2021~~ at 11:00am in the office of the Secretary Government of the Punjab, Excise, Taxation and Narcotics Control Department at ~~Transport House, 11-A Egan Road, Lahore~~ Lahore. No suggestion/objection will be considered after stipulated time.

**PROPOSED AMENDMENTS**

In the Punjab Motor Vehicles Rules, 1969, in the Second Schedule, after para (8), the following shall be added:

- "(9) 'LHC' series shall be assigned to the vehicles under use of judges of Lahore High Court and registration mark shall be displayed on white background with the colour scheme of black alphabets and numerals having a green strip on top of number plate.
- (10) Second proviso to sub-rule (2) of rule 42 of the rules shall also be applicable for the registration marks allotted under para (9)."
