Note: The bidder is expected to examine the Bidding Documents, including all instructions, forms, terms, specifications and charts/drawings. Failure to furnish all information required by the Bidding documents or submission of a Bid not substantially responsive to the Bidding Documents in every respect would result in the rejection of the Bid.

1. INTRODUCTION / INSTRUCTIONS

- 1. The Competent Authority (procurement) Excise, Taxation & Narcotics Control, Punjab invites **sealed bids** from the interested bidders for supply / delivery / installation of connectivity services as per the given technical specifications.
- 2. The procurement process shall be governed by PPRA Rules 2014.
- 3. Bidders are required to submit bids in sealed envelopes, as per PPRA 2014 rules specifying single stage two envelopes procedure. Proponents applying for bids should submit **two separate sealed bids in one envelope**, containing, Technical and Financial Proposals.
- 4. Bidders are required to supply / deliver and install the requisite items as per the given specifications and locations mentioned in the tender document.
- 5. The bidder shall furnish an indemnity bond along with the performance guarantee of 10 % of the total value of the agreed price
- 6. GST number of the bidder must be provided.
- 7. Item wise quantity required is mentioned in the bidding document. However, the Competent Authority reserves the right to increase / decrease the quantity as per the actual need.
- 8. Failure to supply items within the stipulated time period will invoke penalty 2% of the PO Price per month, besides BLACKLISTING of the delinquent supplier as per the PPRA Rules 2014. In addition to that the company will not be allowed to participate in future tenders as well.
- 9. Financial Proposal should contain the rate per unit of the quoted item as per the Technical Specifications, provided under clause 2 of this document.
- 10. Prices shall be quoted in Pak Rupees (PKR).
- 11. The bidder/supplier must have the experience of delivering / installing the same nature of product directly or through authorized partner anywhere in Pakistan.
- 12. The bids shall remain valid for 60 days. Moreover, quoted price should valid for at least 120 days, with effective from the opening of Financial Proposals
- 13. Only Authorized dealers / Manufactures of the mentioned items should apply and also provide the certificates of genuineness and newness from the principal and original import certificate etc.
- 14. The intended bidders are required to purchase this bidding document from the office of the Additional Director General/ Competent Authority(Procurement) Excise, Taxation & narcotics Control, Punjab 847-A,Shadman-I, Lahore on payment of Rs.2000/- (Non-refundable) in the shape of Bank Draft, enables the Firms / Contractor to bid in the prescribed tender.

- 15. The firms are required to submit the two separate sealed bids in one envelope (both Technical & Financial).
- 16. 2% estimated price bid security of the tender must be furnished in the shape of Bank Draft or Pay Order in favor of Additional Director General/Competent Authority (Procurement), Excise & Taxation, Punjab. Bid security is given in following table:

- 17. Bidders are requested to quote their rates inclusive of all Taxes.
- 18. Delivery / installation details of items is mentioned in Schedule-A
- 19. Only GST registered Contractor / Firm should apply.
- 20. 3 Years onsite warranty is required.
- 21. The bidders should clearly mention the Terms and Conditions of service agreements for the supplied equipment / Items after the expiry of initial warranty period.
- 22. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or Proposal.(Rule35(1))PPRA 2014.
- 23. The complete application proposal shall be typed or written in indelible ink and signed by the authorized signatory of the applicant who shall initial each page, in blue ink. All the alterations, omissions, additions, or any other amendments made to the application shall be initialed by the person(s) signing the application. The applications must be properly signed by the authorized representative (the "Authorized Representative")
- 24. Page numbering is must require on complete document with page numbering sequence like Page number 1 of 10. Noncompliance will result into rejection of bid.
- 25. In case of having contradictory statement the bid will be technically rejected.
- 26. Bid must be book bind (sewn or stapled in such a way that it cannot be opened, in case of noncompliance bid will be technically rejected.
- 27. The duration of the contract will be Three (03) years.
- 28. Bidder must have Relevant PTA license (s) (LL/CVAS), PEC and ISO certified in Quality Management Systems 9001:2015, Information Security Management Systems 27001:2013, Health & Safety Management 45001:2018 in Data Service Provider/Telecommunications.
- 29. The bidder must have Minimum Ten years of similar business experience (provide documentary evidence)
- 30. Past experience in last five (05) years (attached copy of five work orders/contracts having minimum worth of 0.5 million in last five (05) years must be provided);
- 31. The Average Annual Turnover for last three (03) years must have 500 Million.

- The bidder shall submit Audited reports in this regard.
- 32. The bidders have minimum three (03) regional offices / Operation Centers in major cities of Punjab. Bidder must provide the complete details with address in this regard. The Procuring Agency may visit the offices for verification of address, infrastructure and documents submitted by the bidder. (if required)
- 33. JV(Joint Venture) is permissible.
- 34. The Service provider will install, deploy, configure, commissioning of all site with auto failover as per the RFP.
- 35. The Service Provider must ensure HSE compliance at all sites.
- 36. The End user shall provide appropriate locations/points and access to service provider for equipment installation. The solution shall allow for bandwidth to ensure end-to-end quality of Service (QoS).
- 37. Service provider will provide high level network diagram upon installations of sites, and will keep on providing diagrams in hard and soft form upon any change or update.
- 38. In-house training before the project will be the responsibility of the service provider for the technical team, all tools and devices will be provided to these technical staff by the bidder, these technical staff will also assist and facilitate to Excise Network manager (IT Operations) online and offline remotely.
- 39. The Service Provider will provide Resident Engineers (10) with all equipment at Divisional HQ's of E&T to support the IT network and Day to Day IT related tasks. The Resident Engineer helps in reducing downtime, evaluates and enhances network performance. They continuously monitor network to improve performance and for protective maintenance. This job requires Resident Engineers to work on-site and for business hour.
- 40. The Service Provider will provide 78 Access Point (2) each at main offices i.e. 20 Mbps(12 sites) and 8 Mbps(27 sites). The Access Point would be Wifi-6 with latest frequency tech enabled 802.11ax/ac/n. Also they should have Master Controller with all the necessary licenses and support. The installation of all these is the bidder's responsibility.
- 41. The Service Provider will provide 40 Rack mounting at main offices i.e. 50 Mbps (1 site) 20 Mbps (12 sites) and 8 Mbps (27 sites) including UPS (uninterrupted power supply) with PSU electric supply each sites. Three patch code of 1-Meter at each site should be properly tagged and use standard color combination throughout Punjab with hardware.
- 42. The Service Provider will provide services and hardware at main offices backup sites i.e. 200 Mbps (1 sites) 50Mbps (1 sites) 20 Mbps(12 sites) and 20 Mbps(27 sites) including switch over load balancer (Gbps) and UPS for this system.
- 43. There should be auto complaint resolution system i.e. after the link down detected in NMS alert, complaint should lounge to companies NOC e-mail, SMS alert should be generated and generate an auto ticket to resolve this issue.
